

Doddington Church No Longer 'at risk'


A lead theft just before the first lockdown in 2020 put St Mary's Church in a vulnerable condition and a potential candidate for the Heritage at Risk Register. Fortunately, with support from the COVID-19 Emergency Heritage at Risk Response Fund, repairs were completed, and a new roof protection system installed. Unfortunately, lead theft is still very much a threat to church buildings. Please ensure you take all precautions including installing an approved security system. Gorefield Roof Repairs Completed

In mid-January repairs to the roof of St Paul's Church were completed. The urgent repairs cost a total of £90,000 which was raised from a variety of sources including grants from the Cambridgeshire Historic Churches Trust and Garfield Weston. MAINTENANCE MATTERS

Recommended Monthly Tasks

From *SPAB's Faith in Maintenance Calendar*.

March

- Check that eaves, gutters and downpipes have not been damaged by frost. Look for cracks and leaks in rainwater goods.
- Clear parapet and valley gutters of snow to prevent melt water rising above them and causing damp internally. Take care in icy conditions.

April

- Check the roofs for frost, snow and wind damage. Look for signs on the ground like broken bits of slates and tiles. Check for splits and cracks in areas of flat or sloping sheet roofing.
- Inspect lead flashings and mortar fillets at chimneys for signs of decay.
- Clear leaves and debris from gutters and rainwater pipes regularly. Cast iron gutters may also require repainting.

May

- Regularly clean out gully and drains to make sure water flows freely away from the building
- Make sure that windows and ventilators are operable so that the building can be ventilated. Lubricate door and window ironmongery and check security of locks.
- Have the boiler serviced, bleed radiators and ensure that the frost thermostat is operational.
- Clear away any plant growth from around the base of the walls and in particular from the drainage channel.



Listed Places of Worship Grant Scheme Extended

The Government has confirmed that the LPWGS will be extended until the 31 March 2025. This three-year continuation is very good news and should enable for longer-term planning for projects. GRANTS CONTINUED

No Change to The National Lottery Heritage Fund (NLHF)

In response to Covid-19, the NLHF focused on six priority outcomes during the last year. These priorities were reviewed last autumn and the NLHF has decided not to make any changes for the period April 2022 -2023. The focus is still on helping heritage organisations recover from Covid-19 and increasing inclusivity and diversity in the audiences they engage with. This doesn't mean that church repair projects will not be supported, but it might take a bit more time to plan the sort of additional activities NLHF want to see.
