- **Synodical processes.** I've been on the Ely Diocesan Synod for 6 years, and previously on the Archdeaconry Synod of the Benelux.
- **Applied theology.** I've been part of the Changing Market Towns working group and theological discussion group for the last few years.
- An **entrepreneurial approach.** We have sought to use innovative ways to reach out to serve some of the most deprived in Huntingdon.
- **Clear communication.** I seek to use jargon-free language in preaching, report writing and local community radio (see below left).
- Ministry across a range of settings within the '**mixed ecology**' of the CofE has taught me that there is room for a diversity of worshipping expressions, all of which need to value one another with generosity.

### My perspective on some current issues...

1. **Covid impact on the church.** The General Synod will need wisdom to grapple with the financial and mental health impact of the pandemic. A focus on church growth will be key to rebuilding rather than managing for decline. Rapid reconsideration also needs to be given to a safe and theologically rigorous way of enabling Holy Communion in both kinds, as we navigate the current phase and safeguard for the future.
2. **Sexuality.** I hold to the apostolic teaching that has been the doctrine of the church for the last two millenia. I believe this is good news for all (including my own LGBT+ friends inside and outside the church). However, LLF has shown us the urgent need to listen with grace and generosity across different perspectives and I am praying that we would all become better at allowing scriptural faithfulness to be expressed in a pastorally sensitive way.
3. **Climate Change.** General Synod's desire for the CofE to become carbon neutral by 2030 is a commendable goal. I was glad to be able to vote for several positive "green" steps at the recent Diocesan Synod debate. Serious work will now be needed to make these happen!
4. **Clergy Discipline.** The process (a fairly blunt tool) needs streamlining so that it is less drawn out, consistently fair and responds proportionally and appropriately to each case.
