Trustees' Report

Year ended 31 December 2024

The trustees present their annual report and financial statements of the charity for the year ended 31 December 20xx. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland effective from 1 January 2019.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Achievements and Performance

On January 1st 2024 Barry I/w Carnoustie and Carnoustie Panbride united to form Carnoustie: Trinity Church of Scotland. A special Service of Union took place on Thursday 11th January when the new Team Ministry of the Rev Annette Gordon and the Rev Mike Goss was introduced.

Annette and Mike have worked together to enable the new Union to become established during 2024. They met weekly to reflect on progress, share Ministry tasks, and plan for the future.

A pulpit exchange was held at the end of November.

Annette is the moderator of the Kirk Session, but Mike stood in for one meeting while Annette was on holiday. Whilst most meetings are held in Panbride Hall, one meeting was held in each of Barry and Carnoustie churches during the year.

Due to the vacancy in Monifieth: South Angus not being filled until September, discussions have yet to begin with the new Minister and the congregation about the future shape of a potential partnership with that congregation. The Annual Evaluation of the Presbytery Mission Plan for Perth has restated the vision for a Parish Grouping between Monifieth: South Angus and Carnoustie: Trinity, and this will be an important area of work for the Kirk Session in 2025, not least in view of the need to determine the future for the Barry Church building.

Social Activities

In Barry the Guild met regularly and continued to be well supported by members and friends throughout the year.

Carnoustie Guild continued to meet regularly but looked to be under threat of closure when they struggled to get new office-bearers. A more informal and shared leadership structure was agreed at the end of the year which has enabled the Guild to continue into 2025.

Newton Panbride does not have a Guild but instead hosts many other frequent social events, including Coffee and Chat, Needles and Pins, Men's Breakfast, the Friendship Circle, and Panbride Musical Memories. In addition, Panbride Hall and Newton Hall continue to be used on an almost daily basis by the congregation and numerous community run groups.

Social Activities (continued)

In June there was picnic in the Panbride Manse Garden and a church BBQ there in September. In August a putting competition was held at Carnoustie Golf Links putting green which was followed by a BBQ in the Carnoustie Manse and garden.

The annual Congregational Day out was to Caulders Garden Centre, Cupar in Fife with lunch at Royal George Hotel, Perth

Fundraising

There were various fundraising events in Panbride Hall during the year including Coffee & Pancake Morning and a Christmas Coffee Morning. The Christian Aid Coffee morning took place in the hall. The well supported Coffee and Chat continued to meet monthly in Carnoustie Church raising funds for the major internal building project there. During the summer Barry Guild organised, well attended afternoon teas in Barry Church Hall and a special one at Christmas.

Funding for the major internal building project at Carnoustie Church received a significant boost with the sale of the Philip Hall being concluded at the end of the year. Earlier in the year the Trustees received approval from OSCR to widen the purpose of the Carnoustie Church Benevolent Fund to support the whole congregation and the wider community by utilising part of the fund for the church improvement project and we look forward to the project getting underway in 2025.

Mission

Messy Church events were held in Panbride Hall in March, June and October. The summer Holiday Club was held in Panbride Hall in August which was supported by other denominations in Carnoustie, but most leaders came from Carnoustie Trinity Church.

During the year Newton Panbride had a visit from 'Good News for Everyone'.

During the year the congregation was invited to attend Dementia Friends Awareness Sessions in Carnoustie and Newton Panbride. In addition a representative of the Royal Life Saving Society UK and St John Scotland held sessions to refresh our CPR and Defibrillator Training.

The congregation also provided shoeboxes for Blythswood Care Shoebox Appeal. During the year various retiring offerings were taken for local and national good causes.

The congregation also sponsored Lachlan Henderson, 1st Carnoustie Boys' Brigade & Girls' Association, who is competing in the World Traditional Table Tennis Championships in China in January 2025.

During the year, members of the Pastoral Care Team accompanied the ministers to the various care homes in Carnoustie for services.

The congregation continues to support 1st Carnoustie Boys' Brigade and Girls' Association with chaplaincy and visits as well as with the BB Christmas Post. Mike Goss continues to serve as an Officer in the Company Section as well as Company Chaplain, while Annette Gordon continues to serve as Battalion Chaplain. The end of session Awards Service was held during morning worship at Newton Panbride, and the Enrolment Service was held during morning worship at Carnoustie.

Annette is also chaplain to 1st Carnoustie Scouts and has supported them in various events this year.

Worship

Services in Carnoustie and Newton Panbride continue to be live streamed, providing worship for both our congregation who are no longer able to attend church and our community. The organists in Carnoustie and Newton Panbride continue to lead the praise and direct the choirs in these places of worship, and we are grateful for their continued support and initiative for our services.

Bible Studies took place during Lent at Panbride Manse and during Advent at Carnoustie Manse. The prayer meeting has continued to meet weekly, usually in a member's home, and at the end of the year there were plans to begin a new monthly prayer meeting for families at the start of 2025. Carnoustie Guild's Bible Study Group meets regularly in a member's home.

The Worship Team as well as being involved with Sunday worship also participated in the Holy Week Morning Services. We also have rotas of readers who read scripture on a Sunday morning in each of the places of worship ensuring that a mixture of voices is heard.

Barry, Carnoustie, and Newton Panbride were all venues for the Holy Week Evening Services along with the church buildings of the other denominations in the town, as we continued our partnership with the other Ministers. The Good Friday Walk of Witness was again an ecumenical witness to the community. Easter Day began with the sunrise service by the beach with breakfast in Carnoustie Church and an early morning Family Service with breakfast in Panbride Hall. An outdoor Easter service was also held in the centre of Barry village in place of the usual morning service in the building.

Our young people from JAFFA and F.O.G. Squad continue to meet.

In 2024, a new Christmas service, 'Carols around the Christmas Tree' took place in the Newton Panbride grounds with the congregation being accompanied by Arbroath & Carnoustie Instrumental Band. A well-attended Christingle service was held on Christmas Eve in Barry with a special offering for the newly inaugurated Barry Community Group. In December Newton Panbride Church was the venue for the Dundee & Angus Battalion Boys' Brigade Christmas Carols Service and the Service of Remembrance and Hope. Watchnight Services were held in Carnoustie and Newton Panbride churches and earlier in the year a bereavement service was held in Carnoustie Church.

In June Carlogie Primary School attended Newton Panbride Church and Woodlands Primary School attended Carnoustie Church for their end of term and prizegiving services and Woodlands returned to Carnoustie Church for their Christmas service.

Also, in June we prepared for the closure of Panbride Church with an Open Weekend in Panbride Hall and a special service in Panbride Church.

Our organists continue to accompany congregational worship and lead the choirs in Newton Panbride and Carnoustie. Recorded music is normally used to accompany worship in Barry.

Flower Ministry

Flowers are donated by members and friends of the congregation and are given to the bereaved in the community as well as to members who are ill or celebrating a special occasion.

At Christmas the Benevolent Funds provided gifts of flowers or plants to members of the congregation who are elderly, have suffered loss or who are infirm.

Church Cleaning Teams

We are grateful to the volunteer cleaning teams for keeping our buildings clean, not only for worship on a Sunday but for both members and the community who use our premises.

AV Teams

The AV Teams ensure our services are live streamed from both Carnoustie and Newton Panbride buildings and that the hymns and readings are projected onto the screens. This enhances worship for those worshipping in person and online.

Financial Review

Due to the union of the three churches 2024 saw an increase in membership which is reflected in the increase in the regular contributions. The membership increase by 638 and the number on the roll at year end was 867.

With the new congregation having three worship centres neither income nor expenditure can be compared with previous years.

As at 31 December 2024, 196 (78 - 2023) members (and their families) contributed by means of regular bank standing orders and of these 164 (64 - 2023) were made under the Gift Aid provisions. The total contributed by this method was £93,676 (£42,779). The freewill offering scheme is also encouraged and during the year 40 (20) members (and their families) contributed £12,382 (£5,782) of which £7,956 (£4,688) was under the Gift Aid provisions. Sixteen of members contribute by means of annual cheques/BACS transfers.

The total amount contributed under the Gift Aid provisions amounted to £105,115 (£83,610) as this includes donations to funds other than the General Fund.

Risk Management

The principal causes for concern are increasing costs and decreasing income and reserves along with an ageing congregation.

Efforts to relieve the position have been undertaken both in controlling costs where possible and focusing on trying to increase members' giving but with inflation continuing at relatively high levels, disposable income continues to be eroded.

Reserves Policy

The charity trustees have considered the reserves required and have taken into account their current and future liabilities. It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted funds of £194,492 of which £17,868 had been designated for Fabric Fund and £55,657 for the Carnoustie Church Project Fund and Carnoustie Church Roof and Buildings Fund. The remaining balance of £120,143 represents about seven months expenditure and while this is higher than would normally be expected the Trustees are aware of the need to repair pointing and stonework on the Carnoustie and Newton Panbride buildings and may use the additional reserves for this purpose.

The church also held £355,857 of restricted funds which have been provided for the purposes specified in Note 12.

Structure, Governance and Management

The congregation is a registered charity, number SC015146 and is administered in accordance with the terms of the Deed of Constitution (Unitary Form) and is subject to the Acts and Regulations of the General Assembly of the Church of Scotland.

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The ministers, who are members of the Kirk Session, are elected by the congregation and inducted by Presbytery.

Under the Unitary Constitution the functions of the Kirk Session are both spiritual and temporal, with responsibility for proposing policy changes as well as overseeing the life, worship and witness of the congregation.

The Kirk Session held 10 meetings over the year.

The trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charity's transactions and disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). Independent Examiner's Report to the Trustees of Carnoustie: Trinity Church of Scotland Year ended 31 December 2024

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 10 to 21.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) effective from 1 January 2019 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities accounts (Scotland) Regulations 2006 (as amended).

Fund accounting

Funds are classified as either restricted funds or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income there from is used for the purpose defined in accordance with the objects of the charity.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

Going concern

The Trustees consider that there are no material uncertainties about the ability of the charity to continue for the foreseeable future, and therefore has adopted the going concern basis in preparing these financial statements.

Recognition of income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received, and the amount can be measured reliably.

Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised. On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

Recognition and allocation of expenditure

Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

Expenditure is included in the Statement of Financial Activities on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure.

Fixed Assets

The charity has the right to occupy & use for its charitable objects tangible fixed assets, including the Churches, halls & manses, vested in the Church of Scotland General Trustees. No consideration is payable for use of these assets. Expenditure incurred on repair and maintenance of these assets is charged as resources expended in the SOFA accounts in the period the liability arises.

Investments

Fixed asset investments are stated at market value at the balance sheet date. Unrealised gains and losses represent the difference between the market value at the beginning and end of the financial year or, if purchased in the year, the difference between cost and market value at the end of the year. Realised gains and losses represent the difference between the proceeds on disposal and the market value at the start of the year or cost if purchased in the year.

Taxation

Carnoustie: Trinity Church of Scotland is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

Cash and cash equivalents

Cash and cash equivalents include cash in hand and deposits held at 31 December 2024 was £477,057 of which £10,279 was with the Investors Trust.

Debtors

Trade and other debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any discounts due.

Creditors

Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.
