**Please remember St John's in the text of your will**

**A NATURAL PART OF CHRISTIAN STEWARDSHIP**

Remembering the church in your will is a wonderful way to thank God for his blessings and help the church meet its needs. Legacy-giving is a natural part of Christian stewardship and down the ages has always been a vital way for worshippers to support their church. In celebration of your life, you may wish to think of St John's in your will when you update it or add a codicil to your existing will.

**The codicil form over the page lets you to add a gift to St John's Boldre easily and quickly if you have already written your Will.**

All you need to do is to complete the codicil form and sign and date it in front of two adult witnesses (who must be over 18 and not be a beneficiary or the spouse of a beneficiary). They do not need to see the contents of the Codicil; they must just witness that you have signed it in their presence. The witnesses should each sign the codicil in your presence and in the presence of each other. Once completed, the codicil should be kept with your original will, but not attached to it.

To ensure your wishes are met, send or give a copy of the Will and Codicil (in a sealed envelope, if you prefer) to your executor, solicitor or other trusted friend, with a note indicating where the original is held.
