Important Information about this Inventory

This inventory was performed during the first half of 2019 and is thus taken as things stood at that point in time. It's possible with the course of time since this inventory that details will change (i.e. decaying inscriptions and monuments).

The churchyard is full of historic monuments, ranging from the earliest in the late 1600 up until the present day. Historic England use the word monument to refer to any structure used as a memorial which includes headstones, marker stones, slabs and chest tombs. Therefore, this inventory uses this definition, and thus everything is a monument.

Over the entire churchyard there are 315* monuments, with a total of 756* individuals named. This doesn't include unmarked graves.

** Out of respect for the families of those interred in the churchyard still living, details from monuments after the year 1970 are **NOT** included in this document. However, the monument's will still show up on the inventory plans with identification numbers but with no form of direct identification. Their details were recorded during this inventory and are available for church wardens to query privately.*

This churchyard was closed to burials in 1983 but there are modern memorial monuments.

Please note:

The inventory shows all names dated before 1970 which appear on any monument. It's important to note that the presence of a name doesn't mean that they were interred at this location, merely that they are named on the monument.

Sadly, errors are possible, most likely due to misreading the inscription or misinterpreting the lettering. If you find any errors, please let a church warden know, or, ideally, contact the author on the details further below.

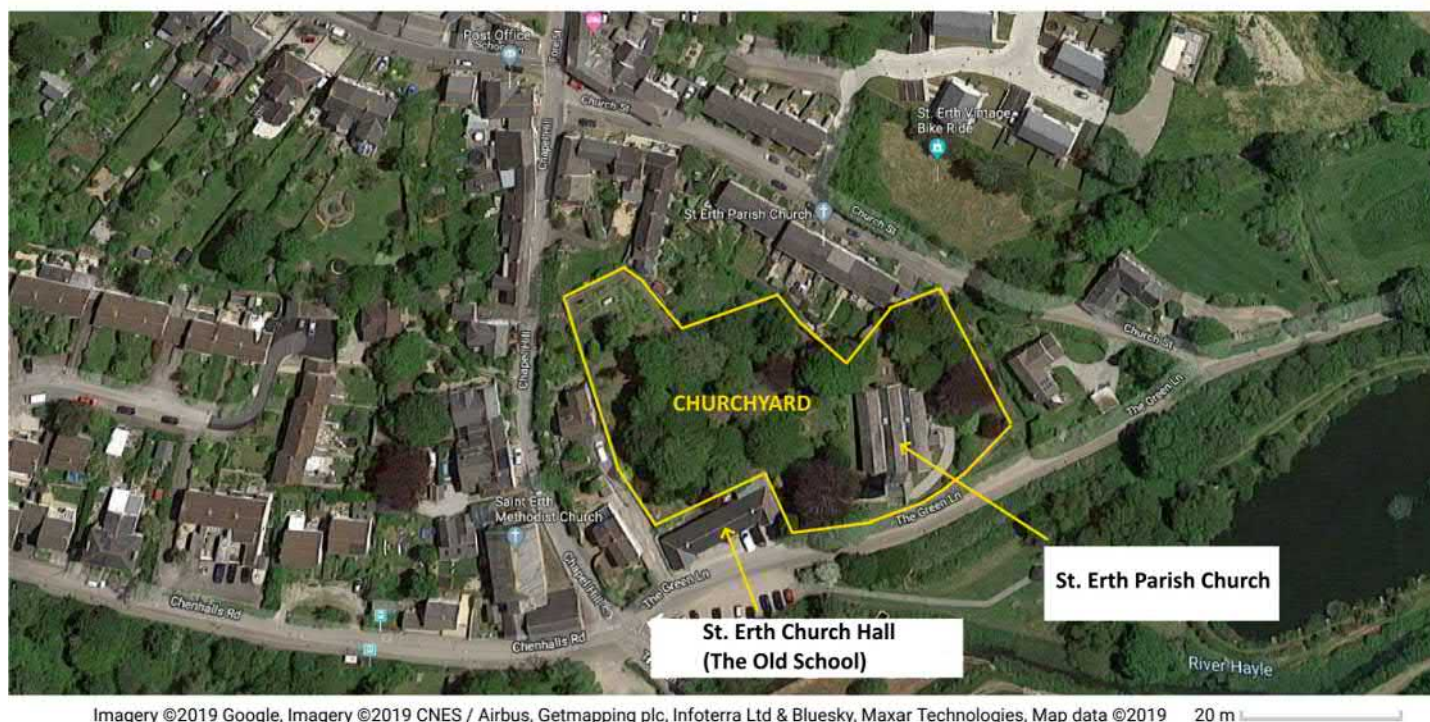
Some inscriptions are unfortunately highly weathered beyond recognition or missing parts of the writing due to parts of the grave itself having cracked off and subsequently lost.

Where there are missing portions of detail with the inscription on some graves, details have been cross-referenced with burial records to suggest the most likely missing information in order to identify individuals. These are educated assumptions based off burial records transcribed by other people, therefore there still sadly might be errors in matching up names.

The following symbols will appear in the inventory:

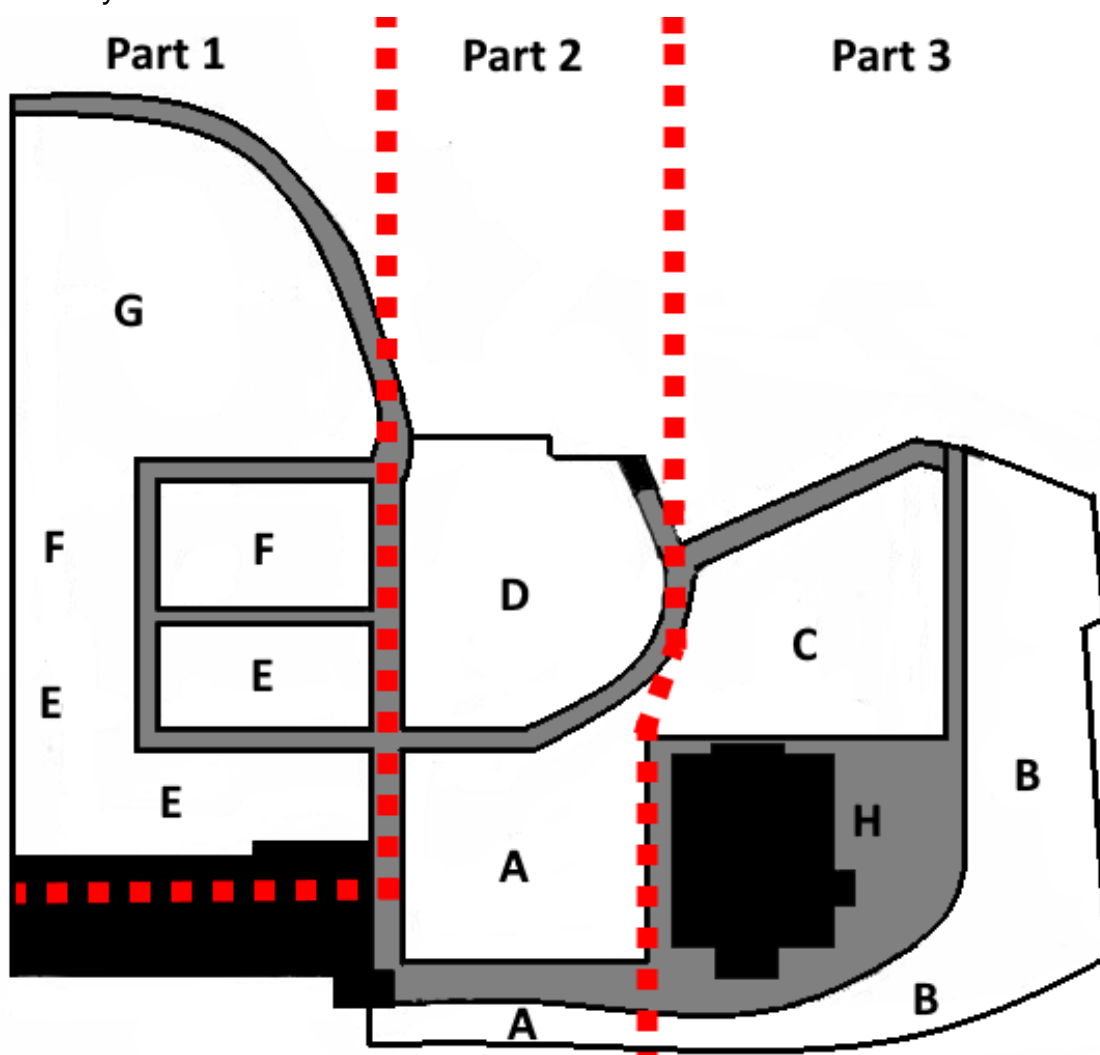
Symbol		Explanation of its use
/	(forward slash)	This indicates that this portion of the inscription was never present in the first place.
?	(one question mark)	A single question mark within a portion (i.e. <u>1?th Mar?h 18?0</u>) indicates that a single character is visible but not legible.
??	(two question marks)	When used a pair of question marks, this is used to indicate a whole word segment (e.g. first name, surname, date) of the inscription is still visible but was not legible. (i.e. <u>15th ?? 1878</u>).
??word??	(two question marks either side of a word)	This is used either side of a word that's part of a segment (e.g. first name, surname, date) to indicate that the inscription is visible but that the word in-between is an educated guess.
—	(two underscores)	This is used to indicate that an entire segment (e.g. first name, surname, date) cannot be read as it is totally obscured or missing due to breakage.

The aerial view below from Google Maps shows the perimeter of the churchyard around St. Erth Parish Church



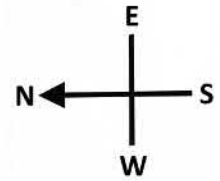
For the purposes of the inventory, the churchyard has been divided into sections, from A to H. Each monument is allocated an individual number within that section. i.e. D45, B2.

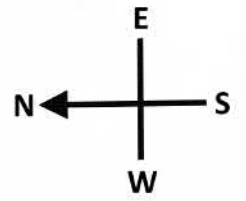

 Section E = blue



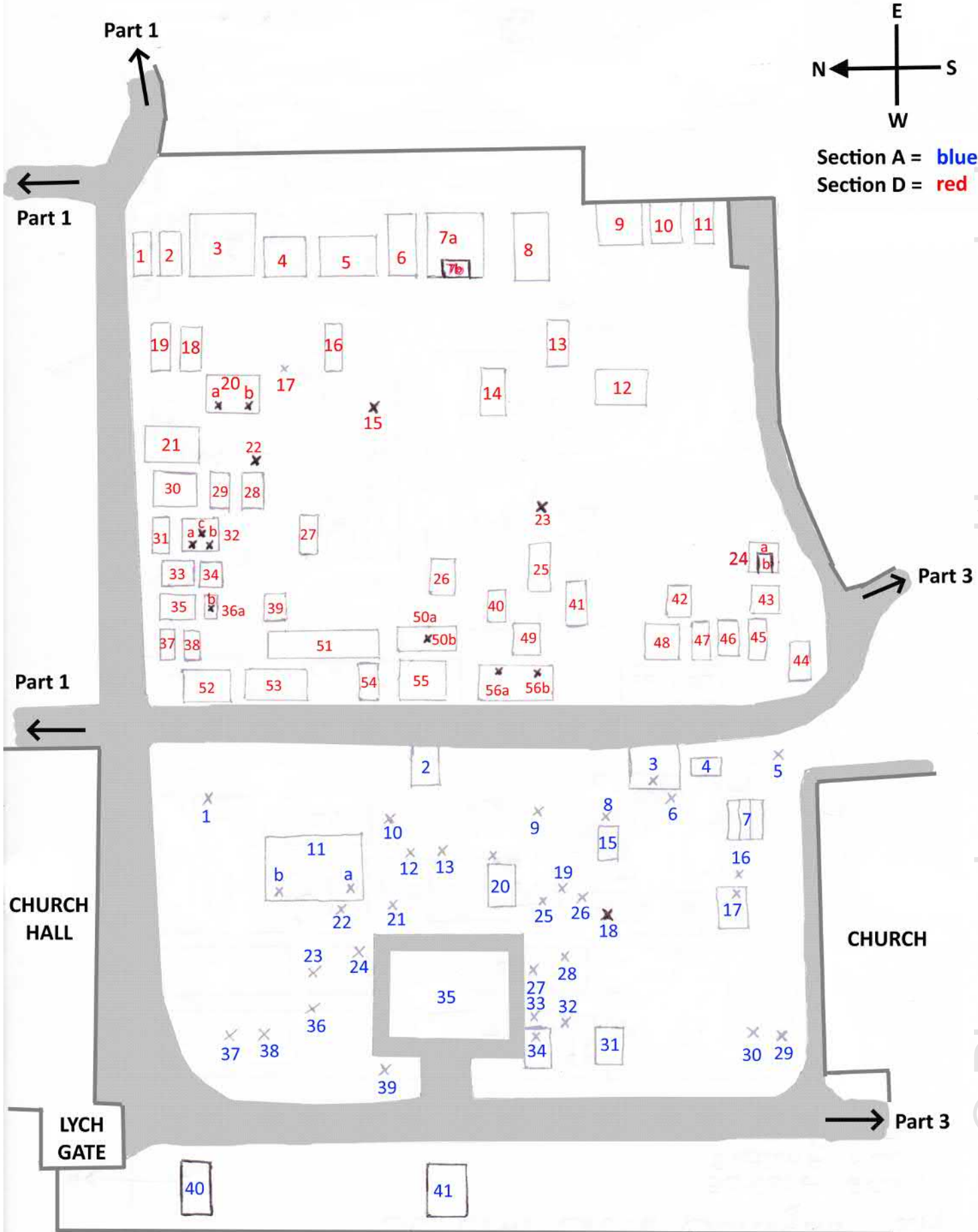

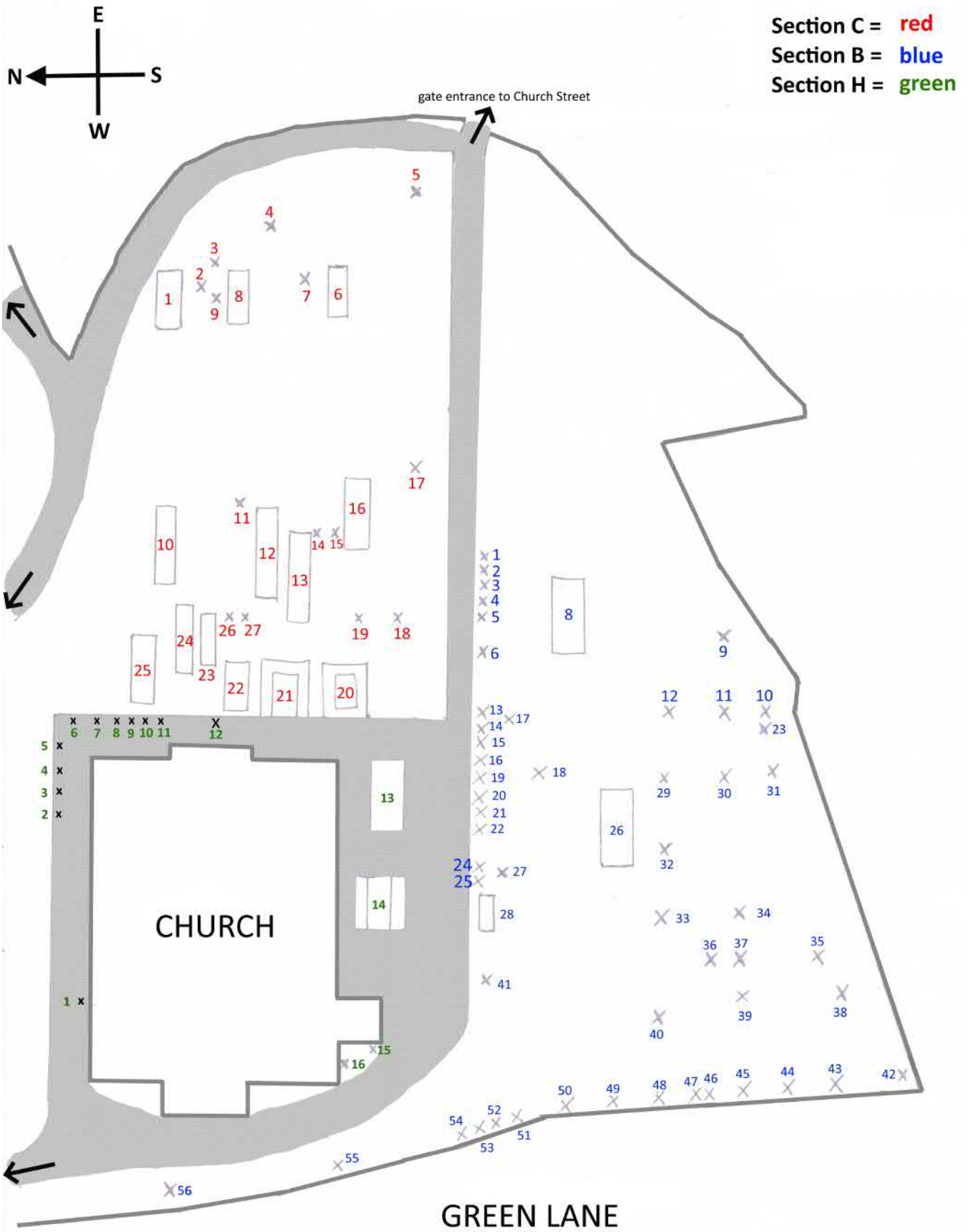
