NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

An application to in three parts, to the church (part 1 and 2) and to the church hall (part 3):

1. PV Solar Panels - an installation of 17 panels fixed on bespoke brackets in discreet locations not visible from street level: 10 to the nave walls above the south aisle roof and 7 panels to the south chancel wall above the flat roof over the chapel. With associated equipment including AC/DC inverter, to feed generated power into the church electricity distribution system and/or to the external supply grid. In accordance with Building Performance Consultancy outline specification revision T5 (dated 06/10/2021), Homeco Energy quotation ref. 130404-02 and drawings entitled "Proposed Panel Locations" and "Cross-section of South Aisle Roof".

2. Chapel Heating - removal of existing redundant gas-fired heater in the chapel and installation of two heat exchangers, boxed in to timber housings, and fed by an air source heat pump sited on the flat roof over the chapel. Ancillary works include a new convection radiator fed by the existing heated water boiler system. In accordance with Building Performance Consultancy outline specification revision 2 (dated 06/10/2021).

3. Re-purposing of church hall rooms - refurbishment of existing office and adjoining meeting room (J4) to create a parish office, with new doorway created within modern stud partition. In accordance with Richard Crooks Partnership drawing no. 97918/01 rev. A and tender specification ref. 97918 (dated October 2020).

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
