NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Works to the area surrounding the Calvary War Memorial in the churchyard including:

- Laying of sandstone riven paving with red St Bees stone edging
- Realigning and resetting of the stone steps leading from the gate to the memorial area. Refurbishment of the sandstone wall either side of the stone steps, including replacement of damaged stone, and rebedding and where necessary replacing the coping stones
- Refurbishment of the cast iron gate from the public footpath and repainting it in black metal gloss

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
