NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Repairs to the Done Recreation Room (church hall) including:

1. Reroofing including stripping off the existing roof, insulating with breathable membrane, putting the slates back on and replacing where necessary
2. Repairs of gable ends including external timber framing and infill panels
3. Repair and repair where necessary of gutters, hopper head outlets and downpipes,
4. Repointing of external stone and brick facing materials
5. Alterations to the interior to improve the fire escape route by forming new opening for fire exit and sealing of existing kitchen door opening onto protected fire escape, and providing and fixing new fire doors.

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
