NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Removal of the existing pews from the nave and making permanent the removal of the pews from the north aisle. Retention and repositioning of one pew under the west window. Introduction of Howe 40/4 chairs to replace the pews.

Construction in the north west corner of a kitchenette and accessible toilet with baby changing facilities

Rearrangement of the space in the north extension to provide large flexible meeting space/vestry area plus separate toilet and baby changing

Provision of storage cupboards to the south west corner.

Fabric repairs including repointing to north aisle, masonry replacement to chimney and replacement of cracked rainwater pipe.

Provision of new M&E and underfloor heating to the nave with new oak engineered floating floor. Replacement of heating pipework and emitters.

Installation of audio-visual system including camera and projector to west end, retractable screen behind the chancel arch, six speakers to the nave area, amplifier, mixing console, processor, subwoofer, radiomics and PTZ camera

New lighting to the church including new LED lighting to kitchenette and toilet in north west corner, and new lighting to the north extension

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.**

### **Directions to petitioner**

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
