NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Overhaul of the clock comprising:

- 1) Removal of complete movement to workshop for washing and cleaning, checking all bearings for wear and polishing all working surfaces, reassembly of the escapement correctly as it was originally designed, resecuring of the escapement pinion onto its arbor.
- 2) Oiling, reassembly and testing of the complete movement.
- 3) On return to site, refitting of the movement back into position, lubrication and servicing of the dial motion works, reconnection of the dials and synchronisation with each other and the movement.
- 4) Reconnection of the auto winding units. Servicing of the hammers and reconnection to the clock movement. Setting up and leaving in good order.
- 5) Fitting of a new auto regulator to ensure accurate time.

### Directions to petitioner

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
