## 1. Welcome and Apologies

Action

Howard Wright welcomed members to the first meeting of the New Year. There were no apologies, but the meeting noted that Howard Short was very unwell and unable to attend.

# 2. Worship & Prayer

Together we sang *10,000 Reasons* and read from Psalm 95. Andy and Jill led us in prayer.

## 5. Pastoral Reorganisation

a. Meeting with Archdeacon, 17th January 2022

The Diocesan Mission and Pastoral Committee (DMPC) met on the 16th December and approved the next stage in the process. We understand that there will now be discussions between the parishes' leadership teams and once there is agreement, the formal 'consultations' will begin.

The Archdeacon introduced John Whale as facilitator of our discussions with St Andrew's, to act as a neutral chair. The initiative for further conversation is delegated to local meetings. No alternative to the single parish/single PCC model has been considered.

## b. Our own process/response.

- i. A temporary (6 month) arrangement whereby Howard W gave cover as priest to St Andrew's for 11am services on 1<sup>st</sup> and 3<sup>rd</sup> Sundays looks like stretching to at least 18 months. On these Sundays it is not practical also to hold communion at COGS 9.30am services. As CofE rules only permit priests to preside at communion/eucharist and if baptisms on non-communion Sundays are factored in, COGS could see 9.30am communion frequency reduced to as little as once a month. St Andrew's does have the support of a retired couple, both ordained, who can offer to preside on one Sunday per month. 4<sup>th</sup> and 5<sup>th</sup> Sundays are usually lay-led.
- ii. It has been necessary to suspend the COGS 7pm service because of low turnout. On some Sundays COGS still offers 8am, 9.30am services plus afternoon Kid's Church or Messy Church.
- iii. We want to improve understanding of each other's communities. So we aim in all our discussions to be flexible, pragmatic, inclusive, to see the Kingdom of God expressed in both, and to protect Howard from excessive demands.

## 6. Other Diocesan Matters

a. Diocesan Carbon Zero strategy

PCC noted with thanks to Mike the paper *Carbon Net Zero by 2030.docx*. We agreed to begin local discussion although if joining of parishes is to go ahead within the timescale there will need to be joint working. For the present, Pam and Pip have agreed to be part of a working party, hoping Mike will do likewise.

#### 7. Finance

#### a. Update

i. David C spoke to his paper PCC Finance Summary Jan\_December 2021.pdf with the figures for 2021 actual and 2022 Budget agreed at the previous meeting and suggested that actual figures so far in January lead to a forecast closely in line with the budget. He also tabled a paper Donation Profile 2022.xlsx showing donation trends 2018-21, and highlighted the sharp drop in planned giving (though the 2021 figure included the one-off donations following Howard's letter November), Gift-aided or not, in 2021. The forecast for 2022 suggests a modest recovery.

We give thanks to God for the turnaround in 2021 from the expected substantial deficit, and for the generosity of individuals.

ii. Changes in patterns of giving.

In response to the Vicar's letter of November 2021 7 had been able to raise regular donations, but 2 for a variety of reasons had to reduce or cancel theirs. On balance there was a small reduction.

There had been special one-off donations in response to specific needs, but no clear trends. We were encouraged to live in Faith <u>and</u> be good stewards of what God has given.

iii. Budget: possible new projects?

COGS has a Reserves Policy designed among things to provide protection for our paid staff. At the time of the meeting, we hold about £25k above that threshold, but a deficit of some £20k is still forecast for year-end. Howard had circulated a paper *Finance reflection from 2021.docx* suggesting some uses for that "extra" sum. David C advised that such money should be used for one-off items, not for recurrent spending that committed similar annual sums beyond this year (e.g., extra staff).

Janet reminded the meeting that there is a Quinquennial Review of the building in 2022. Professional fees will be incurred and there are already known issues with the roof which could require significant expense. She also suggested that there may be scope for reintroduction of tithing to the 6 missions we continue to support.

Jonathan asked PCC to consider sponsoring a young Outreach worker, able to reach young adults.

Timothy reminded us of the Exodus injunction not to keep hold of manna longer than necessary, and to apply the principle to our management of money. Rich asked PCC to think prayerfully overall about a spectrum of spending, £0 - £73k, about where the balance lies. PCC was asked to come to the next meeting to make decisions about the options.

b. Donation in memory of Lisa Bonter

A sum has been offered to replace the worn-out pew copies of the NIV (Anglican) Bibles. The original 1984 edition is no longer available, replaced by the 2011 edition. Funds are sufficient to buy 40 copies. It is not considered appropriate replace the lectern copy which would cost £450. Readers at services can be provided with licensed copies of the appropriate passages weekly. EasyWorship will be updated with the new edition.

He made it clear that he would not head up the financial side of the merger process). He judged that the state of finances of both congregations is healthy at present.
