CHURCH REPRESENTATION AND MINISTERS MEASURE 2019

CHURCH REPRESENTATION RULE 24

A Scheme for the Representation of St Nicholas Bristol on Deanery Synod.

BACKGROUND

- (1) In accordance with Rule 24 of the Church Representation Rules made under the Church Representation and Ministers Measure 2019 ('the Rules') a Diocesan Synod must, at the direction of the Bishop who has made a Bishop's Mission Order which is in force, make provision by a Scheme for the representation on such deanery synods as may be determined by the Scheme, of such persons to whom the Bishop's Mission Order relates as are specified in or under the Scheme.
- (2) The Bishop of Bristol has made a Bishop's Mission Order on 27 September 2018 under Part 7 of the Mission and Pastoral Measure 2011 to provide for the St Nicholas Bristol Mission Initiative.
- (3) The Bishop of Bristol has requested that the Diocesan Synod make provision for the representation of St Nicholas Bristol on the deanery synods for the parish in which the congregation of St Nicholas Bristol meet.

THE SCHEME

The Diocesan Synod of the Diocese of Bristol in exercise of the powers conferred by Rule 24 of the Church Representation Rules makes the following scheme:

1. The Leader licensed to St Nicholas Bristol, if ordained, and other ordained ministers licensed thereto shall ex-officio be members of the House of Clergy of City Deanery in accordance with and pursuant to the Rules.
2. Rule 27A of the Church Representation rules 2020 shall apply with the following amendments:
 - 2.1 the deletion of the word 'and' in 27A(2)(b);
 - 2.2 the substitution and the full stop at the end of 27A(2)(c) with ", and"; and
 - 2.3 the addition of the following as 27A(2)(d): "is not, and does not become, a member of the electoral roll of any parish in which the BMO operates."
3. Such lay persons whose names appear on the Mission Initiative Roll maintained by the Leader of St Nicholas Bristol as are elected in accordance with paragraph 4 hereof shall be members of the House of Laity of City Deanery.
4. Such members of the House of Laity shall be elected at the annual general meeting of St Nicholas Bristol as if it were an annual parochial church meeting electing parochial representatives under Rule 19(1) of the Church Representation Rules 2020.
5. The number of lay representatives for St Nicholas Bristol shall be determined in accordance with the Deanery Synod Election Formula for the time being approved by Diocesan Synod.
6. The election at the AGM of St Nicholas Bristol shall be held not later than 31 May 2022 and thereafter before 31 May in every third year.
7. Model Rule 8 of the Church Representation Rules (the Rules) (which relates to the qualification of persons to be elected) shall apply save that the roll of the parish shall mean the Mission Initiative Roll [and no person shall be nominated for election unless he or she has signified his or her consent to serve].

8. Model Rule 9 of the Rules (which relates to the conduct of elections at the annual meeting) shall apply save that the reference to the annual meeting shall mean the annual general meeting of St Nicholas Bristol and the reference to the roll of the parish shall mean the Mission Initiative Roll.
9. Model Rule 18 of the Rules (which relate to casual vacancies) shall apply so that any vacancies shall be filled by election by the Council Members as soon as convenient and otherwise in accordance with this scheme.
10.
 - 10.1 If the BMO plants new churches then for each of these initiatives, their Leader, if ordained, and other ordained ministers licensed thereto shall ex-officio be members of the House of Clergy on the relevant Deanery Synod in accordance with and pursuant to the Rules.
 - 10.2 Separate electoral rolls for each congregation of St Nicholas Bristol ("the Congregation Roll") shall be compiled by derivation from the Mission Initiative Roll of St Nicholas Bristol.
 - 10.3 A person whose name is on the Mission Initiative Roll shall be entitled to be enrolled on one Congregation Roll if, had the congregation been a separate Mission Initiative, that person would have been entitled to be enrolled on the Mission Initiative Roll of that congregation under Rule 27A(2) as amended above, save that no separate application under Rules 27A(2)(c) shall be required for enrolment on a Congregation Roll.
 - 10.4 The Mission Leader shall keep the Congregations Rolls, and may determine in cases of doubt which roll is appropriate for any particular enrolment, subject to an appeal by the applicant to the Trustee Directors of St Nicholas Bristol.
 - 10.5 If all the congregations under the BMO are in one deanery, the number of lay representatives for St Nicholas Bristol in total shall be determined in accordance

with the Deanery Synod Election Formula for the time being approved by Diocesan Synod ('the Formula') and the number of lay representatives that shall be elected for each congregation shall be apportioned in proportion to the numbers enrolled on the Congregation Roll.

10.6 If one or more of the congregations are in other deaneries the number of lay representatives for each of those congregations shall be determined in accordance with the Formula as if all of such congregations were one congregation and the number of lay representatives that shall be elected for each congregation shall be apportioned in proportion according to the numbers enrolled on the Congregation Roll for each of such congregations.

11. This Scheme shall come into operation upon the date of the session of the Diocesan Synod at which it receives assent and it supercedes all previous Schemes.

SUPPLEMENTARY INSTRUMENT

**MADE BY THE BISHOP OF BRISTOL

**TO SUPPLEMENT THE BISHOP'S MISSION ORDER
COMMENCING 27 SEPTEMBER 2018 IN RESPECT OF ST NICHOLAS BRISTOL**

1.1 This Supplementary Instrument:

1.1.1 supplements the Bishop's Mission Order ("the Order") commencing 27 September 2018 and made under Part 7 of the Mission and Pastoral Measure 2011 ("the 2011 Measure") in respect of the Mission Initiative known as St Nicholas Bristol and is made under section 82 (2) (g) of the 2011 Measure; and

1.1.2 takes effect subject to the provisions of the Order (including the provisions as regards commencement and duration) so that in the event of any inconsistency between this Instrument and the Order the provisions of the Order shall prevail.

1.2 Where the context permits, words and expressions used in the Order shall have the same meaning in this Instrument.

Representation on Deanery Synod

2.1 The persons to whom this Order relates and who are specified in the scheme made by the diocesan synod of the Diocese on 19 March 2022 pursuant to rule 24 of the Church Representation Rules shall be represented on such deanery synod as provided for and in accordance with that scheme.

I, the Right Reverend Vivienne Frances Faull, Bishop of Bristol, make further provision for the Mission Initiative as set out in this Instrument.
