Provision for vulnerable children and critical keyworkers and starting from Monday 23rd March

Dear Parents,

I hope this communication finds you well. It certainly is a bit strange interacting with an audience that is no-where to be seen!

It is clear that the government is trying hard to prevent the spread of the Coronavirus by minimising the amount of contact between children, teachers and their families, whilst also supporting critical key workers in providing emergency services and enabling us to have access to food.

As the rate of people contracting coronavirus continues to increase, we are forever mindful of the part we have to all play in following the government strategy in taking the preventative measures such as social distancing and self-isolation whilst prioritising the care vulnerable and children of critical keyworkers.

The Government guidance makes clear the following important points:

- **If children can stay safely at home, they should, to limit the chance of the virus spreading.**
- **The government has asked parents to keep their children at home, wherever possible, and asked schools to remain open only for those children who absolutely need to attend.**
- **Fewer children making the journey to school, and the fewer children in educational settings, the lower the risk that the virus can spread and infect vulnerable individuals in wider society.**
- **If it is at all possible for children to be at home, then they should be.**

Following on from the previous correspondences both sent out on Friday 20th March, this ongoing message from us communicates the provision of children of critical key workers and vulnerable children, and aims to continue to clarify what this looks like.

- We can, at this point in time, open from Monday 23rd March, **8.30am – 3.30pm**, Monday to Friday.
- This provision will be similar to that provided by Fun Club, we will not be delivering the national curriculum.
- Our offer to parents means there is no requirement for parents to send their children to school if they do not need or wish to do so.
- Every child who can be safely cared for at home should be.
- Our places are limited to in order to minimise the risk to critical keyworkers families, school staff and your own.
- We have strict criteria, as all schools have, and this means that we prioritise places to those families where **both parents** are defined as critical key workers (and have to work at the same time) or a single parent carries this status, as well as those children who have an Education Health & Care Plan or social care intervention and are vulnerable.

- **Many parents working in these critical sectors may be able to ensure their child is kept at home i.e. swapping shift patterns, one parent being able to work from home, split families – the parent not defined as a keyworker may have to care for the child when it is not their contact – these are exceptional times.**
- **Please do not ask the school to make exceptions – if you do not fit the categories described below, your child/children cannot attend school.**
- This provision is very much dependent on the demand
- Staffing levels will affect the running of the provision as it is unknown if staff may need to self-isolate or care for their own loved ones.
- **Please do not turn up unannounced.** You will need to make a request using the form below. A decision will then be made using criteria and you will be notified.
- We are unable to provide breakfast or after school care due to the pooling of all of our resources to enable us to provide this provision.
- If circumstances to the critical key worker demands change – please let the school know.
- To make a request, based on all the information that has been provided, the paperwork **must** be completed returned to school.
- Information on free school meals will be communicated soon.
- **Please note in these forever changing circumstances-** local schools are currently exploring hub provision which could change the provision that Uley School offers

We apologise for being so strict and the disappointment and inconvenience we may cause some families but we do hope you understand the stringent restrictions are due to the nature of the virus and the guidance published – we are here to provide care for children whose parents are **critical keyworkers** when there is no other appropriate alternative.

“Many parents working in these critical sectors may be able to ensure their child is kept at home. Every child who can be safely cared for at home should be. This is an offer to parents and carers and there is no requirement for parents and carers to send their children to school if they do not need or wish to do so.”

Therefore, please only request a place if it is absolutely essential; we want to help those on the frontline, whilst supporting the government strategies for containing the virus, plus wanting everybody to remain safe and well.
