Proposals:	<p>Revised design for inner porch door and step (part of Phase I of wider reordering) Following the DAC's feedback that the previous door design was not of a quality befitting this very significant 14<sup>th</sup> century porch, the architect has revised the design to incorporate a wooden frame with glazing within, with the door leafs extending to the top of the arch instead of having a glazed tympanum, as previously proposed. The subcommittee is generally satisfied with the revised design, except for the monkey bolts, which were felt to be somewhat utilitarian, so the committee may wish to ask that these are omitted or changed.</p> <p>The proposed access into the porch has been significantly revised and simplified, to avoid steps impinging on the moulding of the arch inside the porch. The original intention was to obviate a fall hazard at the large well north of the porch doors in the nave. The parish have been trialling a piece of timber infill here, which reduces and straightens the step down into the porch, with great success in terms of making access safer. They would like to make this permanent in York stone.</p>		

#### November 2022 Minute:

The DAC agreed to recommend this aspect of the proposals, considering the revised porch door design to be much more fitting for its setting. It was suggested that, with the design of the bolts being a little obtrusive, these may need to be revised, and the final could be agreed with the subcommittee in due course. The committee agreed to delegate the issuing of a Notification of Advice for the whole first phase of the reordering (the principle of the rest of that phase having been agreed at an earlier meeting of the DAC) to the CBO and subcommittee, once all of the associated detail has been agreed, subject to the usual provisos concerning CDM legislation and archaeology.

Proposals:	West end extension and internal alterations to the main church. Installation of new heating system utilising existing gas boilers.		

#### November 2022 Minute:

The DAC raised a number of areas of concern over the proposals, as follows:

- The location of the basins within the lobby area of the toilet, which does not have a door. This should be reworked to provide more privacy to this space, either including a door to the area of relocation the hand basins to within the cubicles.
- The detail of the alterations to the door to the baptistry. This is yet to be worked up in detail and a sensitive solution will need to be found.
- The extension was felt to be too small, appearing uncomfortable when considered next to the west end of the church. The pitch of the extension roof (matching the pitch of the nave roof) creates an uncomfortable abutment with the west window, and a maintenance liability. No site plan illustrating the root protection zones and other site constraints alongside the footprint of the extension has been provided, therefore it was not possible for the DAC to understand whether it is possible to increase the

scale of the extension. The size and form of the extension will naturally impact the roof form, which the DAC felt may be better achieved by use of a parapet and lower pitch, or a single pitch.

- The flower preparation area appears to encroach uncomfortably on the area around the font - relocation of the font may be considered necessary.
- The curved form of the servery does not speak to any architectural form within the building and the abutment of the server counter with the colonnade was felt to be uncomfortable and should be reconsidered.

The DAC resolved to delegate resolution of these issues to the subcommittee members.

### November 2022 Minute:

Concerning the question of "due regard", the DAC assessed the submissions in light of the following evaluation matrix ratified earlier in the meeting:

1. Is the plan put forward within the Practical Pathway to Net Zero realistic and proportionate to the size and use pattern/energy consumption of the church?
2. Has the parish taken on board the advice contained within the energy audit/provided by the Diocesan Environmental Team?
3. Are the present proposals being put forward at an appropriate time in their journey to Net Zero?

In applying these questions to Holy Trinity, it was acknowledged that it would not have been possible for the PCC to have complied with the second point at the time of discussion, not having received the Energy Audit. However, the committee considered that the Pathway to Net Zero document provided by the parish needed to go further by putting forward a plan for how the PCC proposes to decarbonise the church's heating system. Clearly, it would not be right for the DAC to mandate modes of decarbonisation, and there may be churches where, applied to heating, this is problematic. But where heating will account for the lion's share of the church's energy consumption and the proposed system is based on a fossil fuel sources, the committee was agreed that any Pathway to Net Zero document would need to demonstrate how PCCs plan to reduce energy consumption and improve efficiency across the board, and particularly with regard to heating.

The committee disagreed with the statement contained within Mr Reading's report that "all experts agree that in general heat pumps are not a good match for historic church heating systems". In fact, the committee considered, in line with the latest guidance from Historic England and the Church Buildings Council, that Air Source Heat Pumps can be ideally suited to underfloor heating systems:

The committee agreed to delegate the decision concerning the proposals to the subcommittee. They were of the view that, without proper demonstration of due regard, or significant revision of the methodology to include a more environmentally fuel source, the proposals cannot be recommended, and that these issues would need to be addressed before a "recommend" NOA could be issued.

<b>November 2022 minute:</b>			
<p>The DAC commented that the plans of the parish are largely aspirational at this point, as the removal of pews had only been trialed for a short period of time. The DAC were encouraging of the parish's plan to use the nave and aisles for community events but felt that there was insufficient evidential data to support the permanent disposal of pews at this point in time. For this reason, the DAC resolved to support the removal of the pews, to be stored for a period of up to 5 years to enable the parish to demonstrate a more evidenced need for disposal.</p> <p>It was advised that the parish use the 5-year window to gather data that demonstrates the impact of the loss of pews on the use of the church, visitor numbers, income and public support.</p> <p>The DAC agreed that the Howe 40/4 wooden frame chair would sit well within the interior of St Matthews. However, it was advised, given the financial commitment of purchasing the chairs, the parish hold off from purchasing them until they are in a position to remove the pews permanently. In the meanwhile, it was advised that the aisle pews are retained and/or cheaper stackable chairs are purchased or borrowed on a temporary basis.</p> <p>It was recommended that the parish gain advice from the Bats in Churches team to establish whether the bats can be encouraged elsewhere in the building. The delay in purchasing the Howe 40/4 chair would also give the parish the opportunity to follow the recommendations of the Bats in Churches team and prevent the bats from staining the new chairs.</p>

Faculty granted for scheme December 2021.</p> <p>The Chancellor directed that the petitioners were to work with their professional advisers and the DAC to:</p> <p>'select and arrange for the re-laying of as many of Street's original tiles as can be salvaged, and to commission as many suitable reproduction tiles as are required, to replicate Street's original design for the nave floor. However I recognise that this may prove to be difficult or impracticable. In this event, the court may be prepared to limit the Street tiled flooring to the central aisle and the north and west ends of the nave, leaving the north and south aisles to be covered by a stone surface.'</p> <p>The full judgement, and report subsequently produced by the parish, are available on the supporting documents tab of the OFS.</p>
